

Key Works:

- Wastewater Treatment Plant (Flow: 400 L/s).
- 13,808 sewer connections.
- 171.3 km of secondary collectors.
- 20.9 km of primary collectors.
- 7 pumping stations.
- 4.4 km of conduction lines.

Beneficiaries: 197,000 inhabitants.

Investment: US\$ 122 million.

Model: State co-financed initiative (23 years).

Award Date: Q2 2025.

Phase: Transaction.

Goal: Improve health and environment in Puerto Maldonado

through safe wastewater treatment.



Key Works:

- 17 km of interceptors/collectors.
- Wastewater Treatment Plant (0.6 m³/s).



Key Works:

Phase 1:

- Huachipa II Plant (Phase 1: 2.5 m³/s; Phase 2: 5 m³/s).
- Huachipa Main Reservoir (160,000 m³).
- 26 km South Branch with 5 reservoirs (69,000 m³).
- Interconnection lines (60 km).

Phase 2:

- Upgrades to Pomacocha and Huallacocha Bajo Dams (38 million m³).
- Trans-Andean Tunnel (10 km).

Beneficiaries: 1.5 million inhabitants.

Investment: US\$ 476 million.

Model: State self-financed initiative (30 years).
